

2. The above earmarked allocation is over and above the outlays communicated earlier and is inclusive of 10% loan component. It is re-iterated that utilization of One time ACA and SPA is subject to formal approval of the Planning Commission and release of funds by the Ministry of Finance, Govt. of India during 2007-08. Further, one time ACA/SPA is meant for creation of infrastructure of critical importance to the State and are to be seen as filling up of vital gaps in the investment requirement instead spreading it over a large number of small projects. This will have the advantage of making it easier for the Planning Commission to monitor the progress on these projects. It is also clarified that implementation of the project(s) under SPA is not allowed to spill over to next financial year. The departments concerned are requested to submit necessary concept paper on each identified project to the Planning Department **on or before 1st October, 2007** for onward submission to the Planning Commission. The matter may kindly be treated as **Most Urgent**.


