### NOTIFICATION

S.O. 1115 (E). – In exercise of powers conferred by Section 5 of the National Highways Act, 1956 (48 of 1956), the Central Government hereby makes the following further amendments in the notification of the Government of India in the Ministry of Shipping, Road Transport and Highways, number S.O. 1096(E), dated 4<sup>th</sup> August, 2005, namely:—
