

**MINUTES OF MEETING HELD ON 26/11/08 AT 1100 HRS. IN THE OFFICE
CHAMBER OF THE DEPUTY COMMISSIONER, EAST KAMENG DISTRICT
SEPPA.**

A Co-ordination meeting of all heads of Officers, Administrative officers and Panchayat Leaders was held under the Chairmanship of Shri Nani Mali, Deputy Commissioner, East Kameng District, Seppa to discuss about the acquisition of land of 45.00 Mtr. ROW for construction of Arunachal Trans Highway (NH-229) from Bana to Seppa. At the outset, the Deputy Commissioner welcome the Members and explained the need and importance of Arunachal Trans Highway by stating that the dreams of people of Arunachal Pradesh of having a road communication connecting all District Headquarters is being realized now. Therefore, parting a fraction of land by any individual should not be a problem for the people of the District.

The Executive Engineer PWD, Seppa, appraised the House about the upto date progress of the Construction of Arunachal Trans Highway and highlighted the scopes and urgency of necessity of preparation of DPR for Compensation Package of the land and properties to be acquired for ROW.

The various speakers suggested the following views:-

1. Shri Bru Sangyu, ZPM, Seppa East, urged for compensation for private properties which are falling on the ROW.
2. Shri M. Kamki, ADC Seppa, enquired about the scope of compensatory package beyond 45.00 Mtr. of the Valley side of the road by stating that 80 – 90% of the excavated materials rolls down the valley side of the road.
3. Shri Tadak Degio, ZPM, Bana in his speech pointed out the ownership of structures constructed under MLALAD/MPLAD and enquired the authority to submit estimate of such structures for compensation. He also suggested for Police deployment/Patrolling all along the proposed Highway during the time of acquisition/demolition of properties falling within the ROW. He, further suggested that the Survey work under Seppa division should be started from 9.00 Km. point instead of 7.00 Km point. To his queries, the Deputy Commissioner, Seppa clarified that all properties constructed under MLALAD/MPLAD and other such assets belong to the District Administration, so the Deputy Commissioner Seppa is the rightful authority to claim compensation and submission of estimates thereof.
4. Shri Sipi Begang, Zilla Chairperson, exhorted to all his PR Member colleagues to extend whole hearted support to department for such noble endeavor. He also said that the compensation package should be discouraged because it will affect the other projects/schemes in the District where provisions of compensation are not available.
5. The Forest Department representative assured his co-operation for issuance of forest clearance but suggested for compensation of the destroyed forest.
6. Shri R.F. Rimo, ZPM, Seppa West, in his speech suggested for finalization of rate/cost of compensation. To this, the Executive Engineer PWD Seppa, explained him that there will be uniform cost of compensation for all over the Arunachal Pradesh.

7. The BRO representative clarified that forest clearance for classification-9 road is available with them which will be submitted to the Deputy Commissioner soon. He also agreed to provide road inventories to PWD Seppa at an early date.

For proper and just acquisition of land of ROW, the Deputy Commissioner Seppa has constituted a Committee consisting of the following members.

He also requested to the Deputy Commissioner to deploy the Police at the time of assessment of the properties as well as demolition during the time of acquisition.

At the last but not the least, when Deputy Commissioner, sought for Voice of Vote from the members present for acquisition of 45.00 Mtr. ROW all along the existing road from Bana to Khodaso road for construction of Trans Highway, the house unanimously passed a Voice of Vote by raising their hands for the acquisition of land.

With this, the Deputy Commissioner expressed his thankfulness to every one for participation of the members in the meeting and expressed his hopefulness for such co-operation in future also.

Thus, the Meeting ended with thanks from the Deputy Commissioner, Seppa.
