The department will not be held responsible for the postal delays, if any, in the delivery of the documents or non-receipt of the same.
2. Bids must be accompanied by security of the amount specified for the work in the table, payable at **State Bank of India, Yingkiong, drawn in favour of Executive Engineer, Yingkiong, PW, Division**. **Bid security** will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
3. Bids under two separate sealed covers for individual packages super scribed as **"Technical Bid"** and **"Financial Bid"** must be delivered to the **Executive Engineer, ,Yingkiong PW Division**, on working days and latest by 1500 hrs on or before 25/03/2010 . The **"Technical Bid"** will be opened on the same day at 1530 hrs in the presence of bidder(s) who wish to attend or authorized representative of the bidder(s). If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. **"Technical Bids"** shall be evaluated by a standing screening committee whose decision shall be final and the bidder(s) who qualify shall be invited to attend the opening of **"Financial Bids"** for which the date and venue will be intimated later on.

4. A pre-bid meeting will be held on 23/03/2010 at 1130 hrs in the office of the Chief Engineer, Eastern Zone, PWD, AP, Itanagar to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "Instructions to Bidders" of the document.
5. The bidder who fulfills the following initial requirements shall only be eligible to participate.
  - (a) Experience of having successfully completed one similar work of aggregate cost not less than Rs 370.00 Lakhs during the last 5 years ending last day of February 2010.
  - (b) Should have had an annual financial turn over in any one year during last five (5) years ending March, 2009 of value Rs.1220.00 Lakhs.
7. The bidder will have to produce no due certificate ( NDC)/ no objection certificate (NOC) from the Arunachal Pradesh state Co-operative Apex Bank Limited, duly issued by the Managing Director cum Chief Executive Officer, Itanagar in order to participate.
8. Other details and other documents to be submitted will be as described in the bidding document.
9. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
