Sub: Land Acquisition for construction of 2-laned Highways in Arunachal Pradesh.

Sir,

The construction of the two-laned Trans-Arunachal Highway was announced by the Hon'ble Prime Minister as a part of the PM's Package on 31-01-2008. This National Highway will cover as many as 11 district headquarters of the State and will traverse a length of 1811 Km from Tawang to Kanubari. Construction of this highway will involve upgradation of the existing road to double lane standards, which in turn will entail land acquisition by the State Government along the alignment of the road.

Prior to the issue of Government notification for acquisition of land, an Executive Order prohibiting all construction activities along a **width of 45 metres both for Open as well as Built-up Areas** is required to be issued by Deputy Commissioner of the districts under their jurisdiction. These widths are inclusive of the Right of Way (ROW) and the setbacks for building lines, which are required to be kept free from all kinds of encumbrances.

These land widths are proposed to be acquired by the State Government as per standard norms guiding construction of National Highways. A recent Executive Order issued by Deputy Commissioner, Papum Pare District on 11-04-2008 for construction of four-laned NH-52A connecting the State Capital along with Gazette Notification No. S.O 1163 (E) published on 16/05/2008 in part II, Section 3, Sub-section (ii) in the Gazette of India, Extraordinary are enclosed herewith for ready reference.

District PWD units will be shortly contacting you for intimating the logistics of the Trans-Arunachal Highway falling under their jurisdiction.

The Executive Order may be issued at the earliest.

EXECUTIVE ORDER

WHEREAS, the Ministry of the Shipping, Road Transport & Highways, the Government of India has notified NH–229, starting from Tawang passing through Nechipu, Seppa, Sagalee, Kheel, Hoj, Ziro, Daporijo, Bame, Aalo, Pangin and terminating at Pasighat; NH–52B, starting from Mahadevpur, passing through Namchik, Manmao, Changlang, Khonsa, Longding & Kanubari and Extension of NH-37, extended from its dead end near Saikhowaghat in Assam to Join NH-52 near Roing (Meka), notified vide No. S.O. 1163 (E) published on 16/05/2008 in part II, Section 3, Sub-section (ii) in the Gazette of India, Extraordinary

AND

WHEREAS, the Ministry of the Shipping, Road Transport & Highways, the Government of India intends to implement the project through agencies like Border Roads Organization and Public Works Department, Arunachal Pradesh for the proposed 2-laned Highway.

AND

WHEREAS, the implementing agencies would be in need of adequate land along the alignment of NH-229, NH-52B and NH-37 (Extension) for the proposed 2-laned Highway.

AND

WHEREAS, the proposed 2-laned Highway will require 45 metre wide in open as well as built-up areas or more.

AND

WHEREAS, the Government is proposing to acquire the required land by issuing Notification, proclaiming the intent of the State Government to acquire the land for 2-laned Highway.

I therefore, Shri ______, Deputy Commissioner-cum-District Magistrate under Section 133 CrPC hereby order immediate stoppage of any construction activities within the specific land width along the alignment of the proposed Highway all along the NH-229, NH-52B and NH-37 (Extension) with immediate effect.
