Sub: - **Recommendation for the Arunachal Pradesh State Awards on the occasion of Independence Day/2008.**

Sir,

I am directed to request you to forward the recommendations for Arunachal Pradesh State Awards on the occasion of Independence Day, 2008 to reach this Department by 15<sup>th</sup> July, 2008 positively as per rule.

The recommendations should be in conformity with the Arunachal Pradesh state Awards on Republic Day and Independence Day Rules 1997 as amended up to 2004.

Special attention may be paid to the following points:-

1. Gold medal should be recommended strictly in accordance with Rule 3(vii).
2. Cases of outstanding merits should be considered.
3. In cases of Govt. servants the prescribed length of service of 5 years or more should be strictly adhered to.
4. The DCs and ADCs having received cases in respect of Govt. servants/ officials for awards will place all such cases as may be found fit by such committee will be recommended by the DC/ADC with citation and other details to the Commissioner/Secretary concerned. The Commissioner/Secretary after receiving such recommendations of the Govt. servants/ officials will obtain approval of the concerned Minister in charge before recommending to Commissioner/Secretary (Political) not later than 15<sup>th</sup> July, 2008.
5. Recommendations in case of non officials will be processed by Secretary (GA) and thereafter depending on the field of outstanding work will submit the recommendations to the Minister in charge/HCM for approval before referring to the Commissioner/Secretary (Political) latest by 15<sup>th</sup> July, 2008.
6. Citation should not preferably be more than 150 words and should be separate sheet for each individual in five copies.
7. Copies of proceedings of the District Screening Committee should invariably be made available alongwith final recommendations.

8. The particulars required to be furnished in the Annexure-A of the rule should be complete.
9. DG Police, Arunachal Pradesh should be consulted before recommending the name (s) of police personnel.
10. The Award recommended should be specified in the citations.
11. No reference should be made for the recommendations sent on earlier occasions. Only fresh recommendations should be sent.
