TERMS AND CONDITIONS:

1. The enlisted contractors will be eligible to tender for building and rod works up to the limit of **Rs. 3.00 Crores (Rupees Three Crores)** in the state of Arunachal Pradesh and such other places outside where the department has construction or maintenance activities.
2. They shall be required to deposit earnest money with each tender as per terms and conditions of the tender/agreement.
3. Security deposit will be recovered from their bills in accordance with the rules in force from time to time.
4. They shall be required to deploy technical staff in accordance with these rules and as per terms and conditions of each NIT/Contract/Agreement.
5. They shall be required to have permanent Engineering Organisation capable of dealing with works of large magnitude in all stages. They shall be required to intimate changes in their Engineering staff as and when such changes are made.
6. They shall be in possession of T & P and equipment as laid down in these rules and as per NIT/Contract/Agreement.
