OFFICE MEMORANDUM

In the light of the directives issued by Ministry of Roads Transport & Highways, Govt. of India vide DO letter No. NH-12037/74/2007/NER/NH-10(Pt) dated 1st July/2008 and reminder dated 18th September/2008 (copies with all annexures enclosed), all Executive Engineers dealing with works of Transport Ministry, Govt. of India are hereby directed to take proper documentation of projects by taking videographs before and after completion of the projects. Expenditure on this account shall be debited to the provision of work contingencies.

The videographs should demonstrate the condition of the road before execution and the improved condition after the execution. Executive Engineers shall ensure submission of video documents in CD/DVD to Chief Engineer-EZ (Nodal Officer) for onward submission to Govt.

Short video clippings shall also be mailed to Nodal Officer for uploading in official website of the department. This is to enhance transparency and visibility of investment being made by Government of India.

Implementation of this OM shall come into immediate effect. Initial phase of documents shall be submitted to this office within **one month from the date of issue of this memorandum.**

Dear Shri Otem Dai,

As you are already aware, the Ministry approves works for execution by State PWDs, Border Roads Organisation and National Highways Authority of India under following schemes/programmes:-

- (i) NH(Original);
- (ii) NH(Maintenance) – Ordinary Repairs, FDR, Periodical Renewals, Special Repairs, etc;
- (iii) Inter State Connectivity (ISC);
- (iv) Roads of Economic Importance (E&I);
- (v) Improvement of State road under Central Road Fund; and
- (vi) SARDP-NE

2. During 2007-08, the Ministry had approved works aggregating to Rs 383 crore in your State, as per the enclosed details (**Annex I**).

3. There is a continued concern about proper utilization of funds and delivering good quality of roads, on time. There are now demands to enhance transparency and ensure visibility of investments being made by the Government. In this regard, I would suggest that the Arunachal Pradesh PWD may ensure proper documentation of the works being executed by it by taking before and after videography. This would facilitate demonstration of the condition of road before execution of the work and the condition of the improved road, after the execution of the work. I would like to inform you in this regard that the expenditure on documentation is already permitted from the provision of contingencies made in the work estimates @ 2.8%.

4. I would request you to issue necessary directions to the concerned PWD officers in the matter and monitor implementation of this requirement. A copy of directions issued may be sent to us.



Dear Shri Bam,

I have reviewed the progress of National Highway works and works relating to improvement of other roads approved under various schemes/programmes of the Department on 24.04.2008 at Guwahati. The meeting was attended by the Commissioners/Secretaries and Chief Engineers of PWDs of all States of North-Eastern region, the Officers of Border Roads Organisation and National Highways Authority of India. A copy of the proceedings of the meeting is enclosed.

2. Apart from many items discussed in the meeting, the following important items were discussed in quite detail in view of their importance:

- i) Capacity building of State PWDs (Para 8 of the proceedings); and
- ii) Quality control and monitoring of SARDP-NE works (Para 9.1 of the proceedings).


3. A concept paper regarding capacity building bringing out action points was circulated in the meeting. Each State PWD was to complete an in-house exercise to formulate a proposal for revamping the organization and the proposal was to be submitted to the Ministry by June, 2008. This has however not been received so far.

4. For proper execution of works, it was decided that the Engineers of one State would be sent to the other State for carrying out inspections. Commissioners/ Secretaries of the PWDs have already been requested vide this Department's letter of even number dated 26.05.2008 to send names of the officers who are willing to carry out inspection in other States. The names of the officers are still awaited.

5. I shall be grateful, if you could kindly look into the matter and expedite action on the issues mentioned vide paragraphs 3 and 4 above.



Proceedings of the meeting held by Secretary to Government of India Department of Road Transport & Highways at Guwahati on 24.4.2008

Shri Brahm Dutt, Secretary, Department of Road Transport & Highway Government of India held a meeting on 24.4.2008 to review the progress of execution of national highway works and the works relating to improvement of other roads approved by Central Government under various schemes/programmes of the Department. The meeting was attended by the Commissioners/Secretaries and Chief Engineers of PWD of State Governments of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim & Tripura, the officers of Border Roads Organisation(BRO) and National Highways Authority of India (NHAI). List of participants is annexed (Annex 1).

2. Chief Engineer (P 10) presented the details of BOS as on 1.4.2008 in respect of NH(O) being executed by State PWDs, the details of which is given below:-

3. Secretary, Road Transport & Highways made the following observations:-

- (i) He mentioned that there is a large amount of BOS and all efforts should be made by PWDs to expedite completion of pending works. He also mentioned that financial constraints will not come in the way and funds will be made available to the performing PWDs, as required by them.
- (ii) He desired that NH(O) estimates for the works included in the Annual Plan Programme 2008-09 already communicated to PWDs should be submitted immediately, so that sanctions can be issued by June end. He mentioned that the

sanction ceiling during 2008-09 may be taken same as the amount of Annual Plan Programme.

4. Secretary, Road Transport & Highways enquired from representatives of States about the requirement of funds under NH(O) during 2008. The representatives of the State Government indicated the following requirement:-

5. **Periodical Renewals**

Secretary, Road Transport & Highways stressed the need of completion of already approved works under Periodical Renewals before the monsoon. He desired that proposals for sanction of new works under Periodical Renewals should be submitted to the Ministry before 15.5.2008. The State Government representatives assured that the requirement of funds under PR will be sent to the Ministry by 15.5.2008.

6. **CRF, E&I and ISC**

While reviewing the CRF, E&I and ISC works, Secretary, Road Transport & Highways informed the State Government representatives that higher allocations can be made to the State Governments in the above-mentioned heads. Additional estimates can also be approved by the Ministry against the unutilized funds of the past years. He desired the State Governments to submit the estimates immediately under the above heads and also send their requirements of funds during 2008-09. With regard to the selection of works under CRF, Secretary, Road Transport & Highways mentioned that priority should be given to the links connecting national highways and those State highways/roads which have the potential of being declared as national highways. He directed Chief Engineer (P

10) to keep the above criteria in mind while approving the CRF works in future. Some of the representatives of State Governments mentioned about the revision of estimates under CRF on account of increase in prices of bitumen, cement and steel and other inputs. Secretary, Road Transport & Highways mentioned that only 10% extra is permitted under the rules and the State Government should meet the extra cost. The representative of Government of Sikkim stated that the State Government is unable to meet the 50% contribution in E&I works. It was decided that possibility of getting such works de-sanctioned and taking up as ISC should be explored. Proposal in this regard will be submitted by the State Government to the Ministry for consideration.

7. SARDP-NE

The Department of Road Transport & Highways has launched a comprehensive programme to construct 686 km long 4-lane highway between Srirampur on West Bengal/Assam border to Silchar as part of East-West corridor and improving 7616 km roads (8737 km as per modified programme approved on 1.10.2007) in all the 8 States of NER under Special Accelerated Road Development Programme (SARDP-NE) to improve connectivity to all State capital towns, District Headquarter towns, backward & remote areas and border areas, besides 4-laning of 1051 km National Highway stretches under NHDP-III to further improve connectivity of state capital towns. The size of the programme is estimated to be over Rs 60,000 crore. National Highways Authority of India, Border Road Organisation and PWDs of State Governments have roles in the execution of the works. In order to expedite execution of the programme, Secretary, Road Transport & Highways made the following observations:-

- (i) BRO and State PWDs should gear up to take up more works and compress the time schedule;
- (ii) 100% land should be acquired and quarries earmarked for materials before award of the work to the Contractors;
- (iii) Monitoring Committee set up under the Chairmanship of Chief Secretary should hold monthly meeting and bottlenecks in the execution should be removed.

8. Capacity Building of State PWDs

A discussion paper was circulated by the Ministry, Secretary, Road Transport & Highways mentioned that revamping of the State PWDs is very crucial to take up the execution of large number of programmes of the Ministry. He mentioned that a specialized cadre in the form of Department of Highways should be set up in each PWD by splitting the cadre. Based on the action taken points brought out in the discussion paper, he desired that an in-house exercise should be completed by PWD by June, 2008 and revamping proposal should be submitted to the Ministry. He desired that the proposal should be approved by July, 2008.

9. General Issues

- 9.1 Secretary, Road Transport & Highways directed CE(P 10) to evolve a system of inspection during execution and external monitoring for SARDP-NE works. He suggested that, if found feasible, the Engineers of one State may be sent to other State for carrying out the inspection. Accrediting the institutions may also be examined and third party inspection should be ensured. He also directed the representatives of BRO and PWDs to ensure before and after videography of the roads being taken up for improvement.
- 9.2 The issue of improvement of NH 62 from Assam/Meghalaya border to km 90, which was under the charge of BRO was discussed. Shri S.P.Sharma, Director, BRO informed that resurfacing has been done from km 43 to 84 and BM&SDBC has been done in 3 km from km 19 to 22, apart from surface correction from km 8.6 to km 20 and km 30 to 91. He informed that one bridge in km 80 will be completed by August, 2008 and another bridge in km 20 is targeted to be completed by February, 2009. The representative of Meghalaya Government was asked to work out the details of further improvements to be taken up to improve the road.
- 9.3 Chief Engineer, Tripura stressed that need of early completion of IRQP on NH 44 between Panisagar to Ambasa. BRO representative took note of it for needful.
