**1. Eligibility Criteria :**

The participants must have successfully executed in Central/State Govt./PSU's three similar works each of value of 40% of the estimated cost or two similar works each of value 60% of the estimated cost or one similar work of value 80% of the estimated cost during last five years. The applications not supported with requisite experience certificate shall not be entertained.

2. The participants must submit proof of possessing T&Ps as required under SCHEDULE "F" of the tender document in accordance with Clause-18 of condition of contract without which tender shall be rejected.
3. The participants must submit proof having Technical personnel's with proof of qualification experience, age, address etc as required under SCHEDULE "F" of the tender document in accordance with Clause-36(i) of condition of contract without which tender shall be rejected.
4. Tender papers will be issued to eligible contractors on production of definite proof from the appropriate authority
5. Tender paper can be purchased from the office of the **Executive Engineer, Ziro Division, PWD, Ziro** on all working days by submitting Application along with experience and on payment of cost of Tender Paper in cash (non-refundable) from. **20/03/2025 to 22/03/2025 (up to 1600 hrs)**. Tender Document requested by mail/post will be dispatched by registered/speed post on payment of an extra amount of Rs. 1500.00. The department will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
6. Tender must be delivered to the **Executive Engineer, Ziro Division, PWD, Ziro** on or before **1130 hrs on 26/03/2025**. The Tender will be opened on same day on **26/03/2025 at 1500 hrs** in the office of the **Executive Engineer, Ziro Division, PWD, Ziro** by him or his authorized representative in the presence of intending tenderers.
7. The Earnest Money of the amount specified above in the form of Fixed Deposit Receipt/Term Deposit Receipt in favour of the Executive Engineer, Yazali Division, PWD AP, Yazali should be enclosed with the Tender document in separate sealed cover.
8. The intending Firms/Contractors should furnish the No-Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued on or after 31/10/2024 by the Managing Director Cum Chief Executive Officer. Tender Paper shall be issued to any intending bidder without submission of NDC from Arunachal Pradesh State Co-Operative Apex Bank Limited.
9. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case maybe.
10. Other document/information required to be furnished by the tenderers are described in the Tender documents.
11. Bidders are advised to inspect the site and its surroundings and satisfy themselves before submitting their tenders.
12. The competent authority reserved the right to reject any or all the Tender without assigning any reason
13. The Tender without earnest money in proper form shall be summarily rejected.
14. The payment shall be made as per allocation of fund according to year wise phasing. The Department shall not be held responsible for delay in payment in case of non-release of fund by the Govt. as per phasing.
15. The APST contractors shall submit ST Certificate to avail relaxation of Earnest Money in favour of them. Original ST Certificate should be produced at the time of opening of the Tender. No relaxation shall be admissible without submission of ST Certificate.
16. The acceptance of tender shall be issued only after obtaining sanction of project from the Govt. of Arunachal Pradesh and Department shall not be responsible in case the project is not sanctioned. If work is not sanctioned within this march'2025, this tender is liable to be cancelled.
