The Executive Engineer, Yazali Division, PWD, Yazali, invites online item rate Tender in Single Stage Double Bid System from eligible bidders of appropriate class for execution of the works as detailed below.

3. Bidding documents can be downloaded from the website www.arunachaltenders.gov.in and the bidding documents downloaded from the website should not be tampered and if any such tampering is noticed before and after the opening of the bids, the bidders shall be penalized and blacklisted.

4. Criteria of eligibility for participation in the Bid.Bidder who fulfills the following requirements shall be eligible to apply. **Joint ventures are not accepted**

- (i) The participants must Experience in successfully completed Bridge work with Approach roads with work value as mentioned below, during the last 05(five) years ending last day of the month previous to the one which Tender is invited.
- Three works each costing not less than Rs. 958.60 lakh (OR)
 - Two works each costing not less than Rs. 1478.40 lakh (OR)
 - One works each costing not less than Rs. 1971.20 lakh (OR)

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of tender.

(ii) The bidder should have average annual turnover (defined as billing for works in progress and completed in all classes of civil engineering construction work only) over the last 5 years of 100% of the value of proposed contract (scanned copy of Turnover Certificate to be uploaded at the time of submission of bid).

(iii) The contractor should have a solvency of minimum **40%** amount of the estimated cost put to bid (Scanned copy of the solvency certificate to be uploaded at the time of submission of bid)


(iv) The bidding capacity of the contractor should be equal to or more than the estimated cost of the work put to tender.

5. The bid can be deposited in electronic format/uploaded in the website www.arunachaltenders.gov.in before the time specified by paying the cost of the bidding documents (non-refundable) in the form of demand draft of Rs. 10000/- (Rupees Ten Thousand) drawn on any scheduled bank in favour of "**Executive Engineer, Yazali Division PWD, payable at SBI Ziro**". Before submission of online bids, the bidders must ensure

- that the scanned copy of all the necessary documents have been attached with the Bids. The department does not take any responsibility for delay caused due to non-availability or slow internet connection or network, traffic jam etc for online bids.
6. The bidders should keep checking the website for any addenda / corrigenda to the notice/ bidding documents till the last date of online submission of bids and the bidders should incorporate the same in their bidding documents.
 7. The bids will be opened online as per time schedule mentioned in this IFB in the presence of bidders who desires to attend on the scheduled date and time in the office of the **Chief Engineer, SID & P, PWD, Arunachal Pradesh**. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same venue and time.
 8. The bids must be accompanied by the bid security of the amount specified above in form of Fixed Deposit Receipt/Term Deposit Receipt of any scheduled bank in favour of the **Executive Engineer, Yazali Division, PWD, Arunachal Pradesh, Yazali**. The bid security should have a validity of 90 (Ninety) days beyond the Bid Validity.
 9. The original documents (Hard copies) for the cost of Bidding Document and the Bid Security (EMD) in the form specified above should be deposited to the Executive Engineer, Yazali Division, PWD, Arunachal Pradesh, Yazali before the date of submission of the Bid as given in this IFB and Receipt obtained, failing which the bidder shall be disqualified. The receipt so obtained should be uploaded/attached with the online bid.
 10. Bid document consisting of disqualification information and eligibility criterion for bidders, plans, specifications, drawings, the schedule of quantities of the various classes of the work to be done and set of terms and conditions of contract to be compiled with by the contractors can be seen on website: www.arunachaltenders.gov.in and scanned copies of the required documents and information as per Section-2 (Formats and Annexure) should be attached in the Technical Bid as prescribed in SBD.
 11. Uploaded documents of bidders will be verified with the original at any time by the Bid Approving Authority. The bidder is liable to provide the original documents to the concerned authority as and when called for.
 12. The bidder may modify, substitute or withdraw its e-Bid after submission prior to the Bid due date. No bid can be modified substituted or withdrawn by the bidder on or after the Bid due date and time.
 13. The intending bidder must read the terms and conditions of NIET carefully. He should only submit his bid if he consider himself eligible for the Bid.
 14. Conditional bids and the bids not meeting the qualification criteria shall be summarily rejected.
 15. The pre-bid meeting will be held as specified in the table above in the office of the Executive Engineer, Yazali Division, PWD, Arunachal Pradesh, Yazali, to clarify the issues and to answer on any matter that may be raised at that stage as stated in Clause 9.2 of the "Instructions to Bidders" bidding document.
 16. **Accessing/ Purchasing of Bid Documents:-**
 - (i) It is mandatory for all the bidders to have class-I Digital Signature Certificate with signing & encryption facility (in the name of person who will sign the proposal) from any of the licensed certifying Agency (Bidders can see the list of licensed CA's from the link www.cca.gov.in) to participate in e-tendering of Ministry of Road Transport & Highways.
 - (ii) User may test the working condition of their Class-I Digital Signature Certificate (Both DSC components, i.e. Signing and encryption) at under "Test Digital Signature Certificate" link.
 - (iii) All profile activation will be done only during PWD/MORTH working days. In order to submit bid response the activation of the vendor profile is mandatory.
 - (iv) The bid documents can be viewed / downloaded from e-tender portal of www.arunachaltenders.gov.in from 31/01/2025 (11.00 AM) to 10/02/2025 (4.00 PM).
 - (v) Following may be noted:-
 - (a) Registration be valid at least up to the date of submission of proposal.
 - (b) Proposals can be submitted only during the validity of their registration.

- (c) The amendments/ clarifications to the bid documents, if any will be hosted on the website www.arunachaltenders.gov.in.
- (d) The original copy of the following document must be submitted before opening of the Technical Bid as given in this IFB:
- Cost of Bid in the form of demand draft.
 - Bid Security or EMD.
 - Affidavit as specified in Section-2 of the Bid document
 - Bank Certificate as specified in Section-2 of the Bid document
- (a) Bidding documents must be hardbound and marked with page number. Every page should be duly signed by the bidder with seal, without which the bids shall be summarily rejected.
- (b) The intending bidders must submit the Site Inspection Report along with shot photograph duly countersigned by the concerned AE/EE without which the bids shall be summarily rejected.
- (c) The Original EMD should be deposited in the office of the Executive Engineer, Yazali Division, PWD, AP, Yazali within the period of bid submission. The EMD receiving Executive Engineer shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format(Enclosed) uploaded by Tender inviting EE in the NIT. This receipt shall also be uploaded to the e-tendering website by the intending bidders up to the specified bid submission date and time.
