The Executive Engineer, Gensi Division, PWD, Gensi, AP, on behalf of Governor of Arunachal Pradesh invites sealed item rate tenders for the following works from the registered contractors in Class- IV & V categories, as per the Govt. of Arunachal Pradesh Extraordinary gaztte notification published on 13th April '2015 gazette No.94, Vol-XXII up to 1400 Hrs on 03.09.2018 and will be opened on the same day at 1430 hrs by the Executive Engineer or his authorized representative in presence of intending tenderer intended to be present.

- The enlistment of the contractor should be valid on the last date of submission/receipt of tender, in case the last date of receipt of tender is extended, the enlistment of contractor should be valid on the original last date of submission/receipt of tender.
- 1.1 The work is estimated to cost Rs.24.00 lakhs. This estimate, however, is given as a rough guide.
- 1.2.1 Tender/Bidding document will be issued to eligible contractor on production of registration card/paper and completion certificate issued by the Engineer-in-charge duly countersigned by the superintending Engineer and the Chief Engineer concerned of having satisfactory completed similar work(s) (similar works means works of the same type of nature) as required in 1.2.4 below.
- 1.2.2 Three similar works each of value not less than 40% of estimated cost or two similar works each value not less than 60% of estimated cost or one similar work of value not less than 80% of estimated cost (rounded off to nearest the ten thousand rupees) in the last 5 years ending the last day of the month previous to the one in which the tenders are invited.
 The value of executed works shall be brought to current costing level by enhancing the actual value of work applying a simple rate of increase of 7% per annum, calculated from the date of completion to the last date of receipt of tender.
- 1.2.3 a) Any contractor who has two (02) or more uncompleted ongoing commitments (projects to executed/contracts at hand) is not permitted to participate in this bidding. A bidder will invariably submit and affidavit sworn before a competent magistrate to the effect that he does not have two (02) or more uncompleted ongoing commitments at the time of bidding. The affidavit should mention the name of the uncompleted ongoing commitment. Any bid which does not fulfill this condition will summarily be rejected. In the event of submission of false information, which may be detected by the Department after award of works, the tender shall be cancelled immediately & the contractor shall be barred from further participation in any tender(s) of the Department.
 - b) Further, a contractor shall be allowed to have only 2 (two) works in hand in any of the Departments under Government of Arunachal Pradesh at a time, in the larger interest of the public and for equitable distribution of development works amongst eligible contractors and also to ensure effective management and quality of works. (SPWD/W-66/2012/314, Dated 13/08/2015).
 - .2.5 The contractor(s) who has/have been awarded the work by call of tenders/bids shall not sublet their work, failing which the authority shall be competent to rescind the contract and take suitable course of action. (Ref. SPWD/W-66/2012/314, Dated 13/08/2015.
- 2. Tender/Bibbing Documents (and additional copies) may be purchased from the office of the Executive Engineer, Gensi Division, PWD, Gensi from 1030 hours of 21.08.2018 upto 1600 hours of 30.08.2018 on payment of cost of tender (non-refundable) as indicated in the above table, in the form of Cash or Demand Draft on any scheduled bank payable at State Bank of India, Basar, in favour of the Executive Engineer, Gensi PWD Division. Interested bidder(s) may obtain further information from the same address. Bidding/Tender Document requested by mail will be dispatched by registered/Speed post on payment of an extra amount Rs.2500.00. the department will not be held responsible for postal delays, if the delivery of the documents or non-receipt of the same.
- 2.1 Tender/Bids shall be accompanied by Earnest Money/Bid Security of Rs 0.24 lakhs in the form of receipt treasury Challan/Deposit at Call receipt of a schedule bank/Fixed Deposit receipt of a schedule bank/Demand Draft of a schedule bank/Banker's Cheque issued in favour of Executive Engineer, Gensi PWD Division. The Earnest Money/Bid Security should be valid at least for 45 days beyond the validity of the bid.
- 2.2. The Tender consisting of financial & Technical Bids & the earnest money shall be placed in separate sealed envelopes each marked 'Financial & Technical Bids' and 'Earnest Money'. All the 3 (three) envelopes shall be placed & submitted in another sealed envelope marked 'Tender' with the name of work and due date of opening written on all the envelopes, which will be received by the Executive Engineer, Gensi PWD Division, upto 2.00 PM on 03.09.2018 and will be opened by him or his authorized representative in his office on the same day at 2.30PM. The envelopes marked 'Tender' of only those tenderers shall be opened, whose earnest money placed in a separate envelop. Bidders who wish to witness the opening of tender may attend

the opening of the tenders/bids. If the day of opening of tenders happens to be a holiday, the tenders/bids will be received and opened on the next working day at the same venue and time.

The competent authority, on behalf of Government of Arunachal Pradesh, does not bind itself to accept the lowest or any other tender/bid and reserves to itself the authority to reject any or all the tenders/bids received without assigning any reason. Any tender in which any of the prescribed conditions is not full-filled is liable to be rejected. Further, if any rider including that of conditional rebate is put forth by any tenderer, their tender shall be summarily rejected.

The contractor shall not be permitted to tender for works in the PWD Circle responsible for award and execution of the contract in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity of are subsequently employed by him and who are near relatives to any gazetted officer in the public works Department.

The tender for the work shall remain open for acceptance for a period of thirty days (30) days from the date of opening of 5. tenders/bids. If any tender withdraws his tender before the said period or issuing of lette of acceptance, whichever is earlier of makes any modifications in the terms and conditions of the tender which are not acceptable to the Department, then the Government shall, without prejudice to any other right or remedy, be at liberty to cause the tenderer/bidder to forfeit 50% of the earnest money and the tenderer/bidder shall not be allowed to participate in the re-tendering process of the work.

The bidder(s)/tenderer(s) will have to produce No Dues Certificate (NDC)/No objection Certificate (NOC) from the Arunachal 6. Pradesh State Co-operative Apex Bank Ltd., duly issued by the Managing director cum Chief Executive Officer, Itanagar along with

the bid/tender in order to participate.

The tenderer/bidder shall submit latest Income Tax clearance certificate or Income Tax Exempted Certificate as the case may be 7. & latest GST clearance Certificate.

The bidder/tenderer is encouraged to visit the project site and obtain necessary information related the bid/tender at the 8. bidder's/tenderer's own risk and cost before preparation of the bid/tender.

Other details, information and documents to be submitted will be as described in the bidding/tendering Document. 9

- The information/documents mentioned heretofore should be submitted in an orderly manner as and where required by indexing 10 them as detailed in the relevant section(s) of the Bidding/Tendering document. The documents and the details must be properly bound in the form of a book with pages numbered. They must not be in loose sheets/pages and in spiral binding. The guarantees certificates, etc from bank(s) and other authorities and other information shall be furnished strictly repeat strictly as per the standard forms given in the relevant section(s) of the Bidding/Tendering Document. They must not be older than three (3) months and must be signed by the competent authority himself/herself with proper official seal. Non-compliance on these counts may lead to rejection of bid on account of non-responsiveness.
- Any corrections or additions that may become necessary shall be notified through corrigenda or addenda in due course of time 11. or in the pre-bid meeting.

The notice inviting tender shall form a part of the contract. 12.
