Bids must be accompanied by Bid security/Earnest Money of the amount specified for the work in the table, in the form of Treasury chelians /deposit at Call receipt of a Schedule Bank/Fix deposit of a Schedule Bank issued in favour of Executive Engineer, Aalo Division, PWD, Aalo . The Bid security has to be valid for 45 days beyond the validity of the bid.
